## About Centre for Research in Schemes and Policies (CRISP)

Centre for Research in Schemes and Policies (CRISP) is an organisation formed by 10 senior civil servants, who have served at the level of Secretary to Government of India, for working with the State and Central Governments for designing/redesigning schemes and policies in the Social Sector. It desires to make large-scale impact by working with State and Central Governments in designing/evaluating/redesigning social sector schemes and policies. CRISP has positioned young professionals led by senior professional in 6 States (Rajasthan, Karnataka, AP, UP, Meghalaya and Telangana).

These CRISP State teams prepare detailed action plans which are approved by the State Govt, implementation of which is done along with the State Govt machinery. The teams conduct 'concurrent evaluation' of schemes, help in setting up monitoring systems, and drafting policies covering rural, urban development, poverty alleviation, education, health and institution building. The objective of CRISP is to bring systematic reforms, thus shifting focus from input-oriented implementation to outcome-focused roll-out. The Consultant (present position) is expected to bring in high degree of knowledge regarding functioning of the higher education with a Master's degree followed by experience of not less than 5 years in higher education sector.

### Leadership

#### **Objective of the role:**

The consultant will be a full-time role in the CRISP Telangana team based in Hyderabad with extensive travel all over the State. The Consultant will be expected to:

- Drive implementation of the HI-STEP project under the leadership of the State Lead and with coordination of the Telangana State Council for Higher Education (TSCHE)
- Provide deep technical and managerial inputs for implementation of the HI-STEP project



- Travel extensively both for understanding the situation, and for monitoring implementation
- Organise training programmes for the academic and administrative staff of the select institutions
- Implement the integration of skills with higher education under the leadership of Sr Consultant (Skills)
- Develop training programs for the stakeholders as mandated in the assessment protocols for evaluation and improvement.
- Work with the team to achieve the goals set in the MoU

# Eligibility

- Master's degree from a top-tier institution is required.
- At least 5 years of work experience in higher education sector
- Should have demonstrated capability in organising and writing professional reports
