About Centre for Research in Schemes and Policies (CRISP)

Centre for Research in Schemes and Policies (CRISP) is an organisation formed by 10 senior civil servants, who have served at the level of Secretary to Government of India, for working with the State and Central Governments for designing/redesigning schemes and policies in the Social Sector. It desires to make large-scale impact by working with State and Central Governments in designing/evaluating/redesigning social sector schemes and policies. CRISP has positioned young professionals led by senior professional in 6 States (Rajasthan, Karnataka, AP, UP, Meghalaya and Telangana).

These CRISP State teams prepare detailed action plans which are approved by the State Govt, implementation of which is done along with the State Govt machinery. The teams conduct 'concurrent evaluation' of schemes, help in setting up monitoring systems, and drafting policies covering rural, urban development, poverty alleviation, education, health and institution building. The objective of CRISP is to bring systematic reforms, thus shifting focus from input-oriented implementation to outcome-focused roll-out. The Consultant (present position) is expected to bring in high degree of knowledge regarding functioning of the school education with a Master's degree followed by experience of not less than 5 years in education sector.

Job description:

The consultant will be a full-time role in the CRISP Andhra Pradesh team based in Vijayawada with extensive travel all over the State. The Consultant will be expected to:



- Drive implementation of the projects given in the MoU with Govt of AP. This consists of driving excellence in 1000 high schools, universalise access of quality pre-primary education and improving learning outcomes through digital education.
- Provide deep technical and managerial inputs for implementation of the project
- Travel extensively both for understanding the situation, and for monitoring implementation
- Organise training programmes for the academic and administrative staff of the select institutions
- Develop training programs for the stakeholders as mandated in the assessment protocols for evaluation and improvement.

Eligibility

- Master's degree from a top-tier institution is required.
- At least 5 years of work experience in the education sector
- Should have deep experience in teacher training
- Should have demonstrated capability in organising and writing professional reports

- Strong planning and organisational skills and an ability to set priorities, plan timelines and meet deadlines.
