Sub: Implementation of **Apprenticeship-Embedded Degree Programmes (AEDPs)** as prescribed by UGC from AY 2024-25 – Reg.

I write on behalf of the [Centre for Research in Schemes and Policies](http://www.crispindia.net) (CRISP) which is an initiative by a group of (10) civil servants, who worked at the level of Secretary to Government of India, to help the State and Central Governments in designing/redesigning/evaluating the schemes/policies in social sector. I worked as Higher Education Secretary, Government of India prior to the formation of CRISP. All members of CRISP work on a 'pro bono' basis on service motto. CRISP has set up a highly professional team for fulfilling the mandate of supporting State Governments. More details about CRISP can be found here: [www.crispindia.net](http://www.crispindia.net)

India is going through a phase of demographic dividend, which will last only for the next 3 decades, where the working age population far exceeds the dependent population. However, benefits from this are conditional to the working age population being skilled and productive. Unfortunately, nearly 80% of the students coming out of the higher education system are adding to the list of unemployed every year. This poses a serious challenge threatening to nullify the demographic dividend, unless expeditious steps are taken to rectify the situation. One of the important directives of the NEP 2020 was to impart employable skills in the students so that they will participate in the nation's economic growth. In July 2020, UGC issued guidelines for the implementation of **Apprenticeship Embedded Degree Programs (AEDPs)**. However, the progress in this respect is tardy since bringing the industry and academia together needed special efforts.

In this scenario, to enhance the employability of students, CRISP initiated the **National Initiative for Skill Integrated Higher Education (NISHE)** for implementation of AEDPs by coordinating with [Sector Skill Councils \(SSCs\)](#), the industry, and the State Governments from AY 2023-24. AEDPs are designed by integrating skill sets into the curricula by following the UGC guidelines. In AEDPs, students earn-while-they-learn by going through one-year apprenticeship in their final year, after which they get assessed by industry for their placement. With the continuous efforts of CRISP, AEDPs are being implemented successfully in the states of Andhra Pradesh, Telangana and Uttar Pradesh in various sectors benefiting 2000+ students.

Recognizing the potential of AEDPs in skilling the students and enhancing their employability prospects, CRISP is working on a mission mode to expand the implementation of AEDPs to other states with diverse sectors at a larger scale impacting a greater number of students. In this regard, a Centre of Excellence (CoE) for implementing the National Initiative for Skill Integrated Higher Education (NISHE) is established at CRISP. NISHE proposed to scale up the AEDPs to 10 states involving 11 sectors targeting 1 lakh students over a period of 3 years. The details are enclosed with the letter.

Considering the progressive steps being taken by your State, we propose to work together to introduce AEDPs starting from 2024-25 as per the enclosed Statement. This doesn't cost the State Government anything, since we will be mobilizing resources for the development of curriculum, training of teachers and monitoring of the programme. Besides, CRISP works pro-bono and on a 'no cost' basis to the State Govt. However, in case any Labs are required for course implementation in the Government colleges, that cost would need to be met by the State Government, and it is a one-time investment.

Considering that the AY 204-25 is fast approaching the following is timelines proposed:
